The sealed tenders are invited from the interested registered firm of van body builders for making of a new body hearse van / dead body van on a Mahindra & Mahindra pickup van under CDM & PHO, Bhadrak for utilization in the Basudevpur Block of Bhadrak district which is donated by Hon'ble M.P LAD, Bhadrak.

The tenderers have to submit the valid firm registration, body building certificate, valid PAN and GST with the tender paper. The tenderers will quote the rate of the hearse van body A.C with SS structure of the body and use of materials quality in details including labour charges and coloring etc. with full body building. The tenderers will quote the bidding amount along with GST. They have to submit the body building certificate for a period of 3 years related to the building of hearse van / dead body van.

The sealed tender should reach the office of the CDM & PHO, Bhadrak through registered post / courier on or before 07.01.2023 up to 5 PM. The sealed tender received after due date shall not be considered. The tender will be opened on 10.01.2023 at 11:00 AM in the office chamber of CDM & PHO, Bhadrak in presence of tenderers or his representative who has knowledge of hearse van body. 
