



1. Sealed tenders are invited from the intending registered firms/Suppliers/Authorized Delars within Bhadrak District for supply of stationary articles/equipments to Anganwadi Centers under ICDS Project, Dhamnagar .The tenderers shall have to drop tenders into sealed Tender Box kept in Office of the Child Development Project Officer, Dhamnagar from date 17.02.2023 to 27.02.2023 (until 5:00 PM) and will be opened on dated 28.02.2023 at 03:00 PM in the Office of the Child Development Project Officer, Dhamnagar in presence of the Tender Committee members and tenderers or their authorized representatives. The detailed regarding tender documents, terms & conditions & list of item can be obtained from the office of the Child Development Project Officer, Dhamnagar on payment of Rs.5000/- (Rupees Five Thousand) only. The money should be deposited by the tenderers in shape of cheque /DD in favour of Child Development Project Officer, Dhamnagar towards cost of the tender paper from date 17.02.2023 to 27.02.2023 in any official working day from 10.00 AM to 2.00 PM. The cost of the tender paper is non refundable.
2. The tender papers should be submitted in a sealed cover super scribing in **block letters** such as "TENDER FOR SUPPLY OF STATIONARY ARTICLES FOR AWCS & ICDS PROJECT, DHAMNAGAR.
3. The Original tender paper should be filled by the tenderer properly & legibly without any correction/ overwriting & shall be submitted along with Anneaxure-1
4. The tender shall quote one rate for one item as per the given specification. The unit rate for the individual sub-items will not be taken into consideration the final rate including all taxes and transportation charges up to ICDS Project, Dhamnagar.
5. The tender paper will be received through tender box kept in office of the Child Development Project Officer, Dhamnagar by Hand /Post (Speed/Regd.). The Telegraphic /Conditional Tender will not be accepted. (The undersigned will not be responsible for postal delay if any or non-receipt of the tender papers in time.)
6. Earnest Money of Rs. 100000/-(Rupees One Lakh) only should be deposited by the tenderer in shape of NSC/Term deposit/BD any Nationalised Bank in favour of the Child Development Project Officer, Dhamnagar and it will be enclosed along with tender paper. No tenderer shall be allowed to withdraw his Earnest Money before finalisation of the tender.
7. Earnest money deposited by the successful tenderer will stand converted to security deposit which will be refunded .In case of the supply of the low quality of items, the whole or part of this deposit will be forfeited.
