

## TERMS AND CONDITIONS

01. The bidder/Supplier should be a bonafied registered body.
  02. The bidder/Supplier should have valid PAN & GST Registration certificate.
  03. The bidder/Supplier will have to submit the Affidavit (on original stamp paper of relevant value) with following clauses:
    - a. Our bidder/supplier has not been blacklisted by any Government Organization.
    - b. Our bidder/supplier does not have any legal suit / criminal case pending against it for violation of GST Act or any other law.
    - c. That the bidder/supplier agrees to abide by all terms & conditions of tender.
    - d. The bidder/supplier will quote prices inclusive of all taxes.
  04. The tender must be accompanied along with the tender paper cost of Rs.600/- in shape of Demand draft drawn in favor of "ZSS NON NRHM FUND" Bhadrak payable at Bhadrak. The amount is not refundable.
  05. The tender must be accompanied by EMD of Rs.1500/- in the form of deposit receipt of scheduled Bank/Kissan Vikas patra/Post Office Savings Bank Account / National Savings Certificate / Postal Time Deposit Account/F.D duly pledged in favour of CDM&PHO, Bhadrak
  06. The <sup>1st</sup> lowest tenderer whose tender is selected for acceptance shall within a period of seven days upon written information being given to him of acceptance of his tender make an earnest money 1% and initial security deposit @ 1 (One percent) of the quoted amount.
  07. Supplier shall also ensure that the quality and quantity has to be as per the supply order and approved rate contract. The supply of the item shall be made immediately (within 15 days) after placement of supply order against the place mentioned in the supply order and supplier shall submit the bill for payment at the approved rate in respect to quantity of items supplied.
  08. Conditional tenders are liable to be rejected. In the event of acceptance, decision of CDM&PHO, Bhadrak will be final. The tender, which is not as per our required specifications, will not be considered.
  09. The CDM&PHO, Bhadrak will not pay any advance payment to the Supplier/Bidder. The Supplier/Bidder will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regard.
