

**PROCEEDING OF THE DISTRICT LEVEL SELECTION COMMITTEE  
MEETING OF SCHOOL FOR THE BLIND, BETARA, BHADRAK HELD ON  
09.03.2023 AT 1.30PM.**

A meeting of District level selection committee of School for the Blind, Betara was held under the chairmanship of Collector & District Magistrate, Bhadrak on 09.03.2023 at 01.30PM in his office chamber.

The following members were present on the meeting.

1. Additional District Magistrate, Bhadrak
2. Sub-Collector, Bhadrak
3. District Education Officer, Bhadrak
4. District Social Security Officer, Bhadrak
5. Subject Matter Expert (Trained in Visual Impaired)
6. Headmaster I/C, School for the Blind, Betara, Bhadrak

At the outset DSSO, Bhadrak welcomed all members of the committee and discussed the aims and objective of the meeting. He also discussed about filling up vacant posts i.e.

- (i) Assistant Teacher (Trained Intermediate)- One post,
- (ii) warden/Matron- One post,
- (iii) Attendant (Female)- One post

The Collector-Cum-Chairman of the committee and other members wanted to know that requisite qualification of the above post and the process of advertisement as per Govt. Guidelines to invite applications. DSSO, Bhadrak placed in details before the committee, that advertisement was done in two daily odia wide circulated news papers and Bhadrak District web portal ([www.bhadrak.nic.in](http://www.bhadrak.nic.in))

The collector & District Magistrate, Bhadrak instructed to DSSO, Bhadrak to discuss about status of the applications received. DSSO, Bhadrak placed the status as given below.

The DSSO, Bhadrak presented the marks secured by the candidates for the post of trained Intermediate teacher and Warden/Matron before the selection committee members for verification and scrutiny. After due verification, the selection committee members unanimously selected the following candidates to the different posts as detailed given below.

**1. Trained Intermediate Teacher - One Post for School for the Blind, R.N. Betara**

The requisite qualification for the said post is +2 pass or its equivalent, RCI, Recognised Diploma in Special Education (V.I)

Out of 21 valid candidates, 8 candidates were +3 and B.Ed in Special Education(V.I), 7 Candidates were +3 and Diploma in Special Education(V.I) and 6 candidates were +2 and Diploma in Special Education (V.I). The Committee decided to select the candidate with higher qualification in order of merit i.e +3 and B.Ed in Special Education(V.I) for benefit of the students, among higher average percentage of marks. It was also decided and next 2 candidates of the final merit list were enlisted in the waiting list alongwith the selected candidate. The details are mentioned in the table below:-





### 3. Attendant (Female)- One Post for School for the Blind, R.N. Betara.



It was unanimously decided not to appoint any candidate for the post of Attendant (Female) from among the applicants in response to the present advertisement vide No.130/SS dard 13.01.2023 Sl. No.- 3 and DSSO, Bhadrak was directed to take step immediately for fresh advertisement for the post of Attendant (Female).

Finally the selection Committee decided to publish the result for the post of T.I and Warden/ Matron in the NIC website of Bhadrak District for general information of candidates & the DSSO, Bhadrak was instructed to issue appointment order to the selected candidates under intimation to SSEPD Deptt.

The meeting <sup>was</sup> ended with vote of thanks to the chair.






