## AUCTION CALL NOTICE

The tenders for auction of unsold Paddy seeds available in the Govt. Seed farm, Bhadrak, Dhamnagar & Agarapada to be held on Date: 31.05.2023 at 11 AM in the office of the undersigned. The Authority required sealed Tender/Auction papers from the intending bidders for auction of the unsold Paddy of Q. 574. The bidders have to deposit Rs. 1000/- (Rupees One Thousand) only towards earnest money in the office of the undersigned on or before 31.05.2023 at 9.00 AM. As per the following terms & conditions, the Authority reserves all the rights to accept or to cancel the bid whenever necessary. The earnest money will be refunded to the unsuccessful bidders in any office day after completion of the auction.






