

### Terms & Conditions

1. The intending tenderers/bidders interested to buy the aforesaid vehicle are required to submit their highest quotations in sealed cover with their full address in the enclosed proforma, addressed to the **Chief Development Officer-cum-Executive Officer, Zilla Parishad, Bhadrak, At-Charigharia, P.O.-Madhabnagar, Dist.-Bhadrak, PIN-756181**. First preference shall be given to the Govt. agency and thereafter private institution/party.
2. The sealed Quotation super scribed "**Tender for sale of 3 (three) nos. Road Roller**" on an envelope completed in all respect should reach the undersigned on or before **31.07.2023 by 1.00 PM** through Registered/Speed Post only. The Quotation will be opened at the chamber of the undersigned on the same day **at 3.30 PM** in the presence of the bidder /his or her authorized person/representative.
3. The interested bidders/tenderers may submit their bid application along with EMD of **Rs 5,000/- x 3 = Rs.15,000/- (Rupees fifteen thousand) only** for three Road Roller in shape of Account Payee Bank draft drawn in favour of **Chief Development Officer-cum-Executive Officer, Zilla Parishad, Bhadrak**, payable at any Nationalized Bank/ Scheduled Banks of Bhadrak and be submitted along with the tender papers as security deposit. **The applicant have to apply for all 3 (three) Road Rollers at a lump. There is no scope to apply for single road roller at a time.**
4. Late/delayed & tender received without Earnest Money Deposit (EMD) in shape of Bank Draft shall not be accepted.
5. The vehicle is offered for disposal on "**AS IS WHERE IS BASIS**" & no guarantee for its worthiness or quality will be given by this deptt..Taxes and duties if any that may be levied by Government will have to meet by the buyer.
6. The bidder may inspect the above vehicle on any working day from **17.07.2023 to 29.07.2023 between 10:30 am to 3.00 pm** in the premises of the Office of Zilla Parishad, Bhadrak.
7. No Complaint whatsoever will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.


8. The successful bidder shall have to deposit 25% of the bid amount immediately after announcement at the spot and rest amount within 7 days from the date of auction/approval, failing which the aforesaid deposit of EMD will be forfeited.
9. EMD of the unsuccessful bidder will be returned immediately after finalization of the award to successful bidder. EMD of the bidder who fails to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this office.
10. The delivery of the sold vehicle will be given only after the successful bidder submits the documentary evidence in support of residential status (**Voter ID/Aadhar card/Ration card in case of individual and Registration certificate in case of firm etc.**)
11. The sold vehicle shall have to be removed by the successful bidder within 7 days at his own expenses from the premises after the date of full payment of the tender amount.
12. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of 1% of the tendered/negotiated money shall be charged for each day or part of the day till removal of the vehicle from the site.
13. Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle. The amount deposited by him/her shall be adjusted towards the ground rent and the vehicle shall become absolute property of Government free from all encumbrances.
14. The EMD amount of Rs.15,000/- for three Road Roller will be adjusted towards the sale amount.
15. The successful bidder will also be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost expeditiously. This Deptt. will not be responsible for any lapse on his part in this regard.
16. The successful bidders/tenderers shall not be allowed to withdraw his bid, failing which his EMD will be forfeited.
17. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reason arise, the same will be opened the next immediate working day at the same time.
18. If the highest quoting firm fails to honour the bid; the contract will be cancelled and its EMD will be forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid.
19. The competent authority reserves the right to accept or reject any/all of the quotations without assigning any reason.
20. If any legal dispute arises the matter shall be settled within the jurisdiction of Bhadrak District only.




