Sealed tender has been invited in the prescribed formats from the intending reputed Indian Manufacturers/ Suppliers / Agencies/ Companies/ their Authorized Dealers / GeM approved registered Firms having valid GST Registration for supply of **Amenities for personal entitlements i.e. Dual bench desk, Study table, Blanket etc.** as specified in **Annexure – II** to be provided to the different residential School hostels functioning under ST & SC Dev. Department of Bhadrak District.

Term & Conditions

1. The sealed tender should be sent by Regd. Post/Speed post only addressed to the District Welfare Officer, Collectorate, Bhadrak, At/Po-District Bhadrak, PIN-756100 & super scribing "Amenities for personal entitlements i.e. Dual bench desk, Study table, Blanket etc."
2. Two Bid System: There are two parts of the tender documents i.e. Technical Bid (**Annexure – I**) and financial Bid (**Annexure – III**). The bidders are required to fill out all the two parts of the tender documents and place them in two separate sealed envelopes, which should be super scribing "Tender for supply of Amenities for common facilities (Kitchen utensils)–**Technical Bid**" and "Tender for supply of Amenities for common facilities (Kitchen utensils)–**Financial Bid**" respectively. Financial bids of technically qualified bidders will only be opened.
3. EMD & ISD:- Successful bidders should deposit EMD@1% of the estimated cost & ISD .5 % of the tendered value only in form of Bank draft in favor of "**District Welfare Officer, Bhadrak**" from any Nationalized/ Scheduled Bank.
4. The committee reserves the right to reject or cancel/alter/modify/add any terms and conditions at the later state without assigning any reason thereof.
5. The committee shall not be responsible for any postal delay or missing of tender papers. The incomplete tender paper without EMD & ISD after the scheduled date and time shall not be accepted and liable to be rejected.
6. The parties have to quote the rate for the items inclusive of GST, all other taxes, other incidental charges, packing and transporting cost to deliver at **concern residential SSD School point** of Bhadrak District.
7. The committee has also reserved the right to consider or select the item basing upon the quality of the product.
8. The intended party will submit the tender documents completely in all respect along with EMD, ISD and other required documents on-or before **18.11.2023, up to 05:00 PM** addressing to District Welfare Officer, Bhadrak. District Welfare Officer, Bhadrak will not be responsible for any postal delay.
9. The authority has every right to extend the dateline for submission of tender.
10. The tender received by the authority after the scheduled time and dateline will not be accepted. Thus, the same is deemed to be rejected.
11. Incomplete tender received without ISD & EMD will not be considered as per the terms & conditions laid down OPWD code.
12. The tenders will be opened on the scheduled date & time at Collectorate, Bhadrak in presence of tenderer or their authorized representative if they desire so.
13. No. of quantity required may vary as and when required by the District Welfare Officer, Bhadrak.
14. If L-1 bidder does not turn up to provide after finalization of the tender, then he/she shall be debarred from participation in bidding, in that case L-2 bidder will provide the items if fulfills the required criteria with subject to the condition that as per the rate quoted by L-1 bidder otherwise the tender will be cancelled.
15. The words & figures shall prevail the tender shall be written legibly & free from erasures, overwriting or correction figures where unavoidable should made by scoring out, initially dating & rewriting.

16. Specification:- the item must be of the description and specification (both physical and technical) as given in the bid document.
17. Rate:- the cost of the item to be mentioned by the Tenderer shall be inclusive of all taxes as applicable including packing & forwarding charges loading, uploading charges transportation charges & installation charges if any.
18. Tender paper and submitted documents should be signed in each paper by the tenderer.
19. Delivery of goods:- supplier/dealer has to supply the items within 10 days from the date of placement of order.
20. Inspection & verification:- payment will be made only after detail inspection of quantity and quality of items.
21. The supplier will have to bring one **sample piece each items as specified in the tender** at their own cost in order to **ascertain the quality of material** as per specification on the opening date of tender for finalizing the tender in presence of tender opening committee.
22. If the above stated opening or closing date (s) happens to be Govt. Holiday(s) / *Bandh*, the submission /opening of the tender will be on the next working day as per the time scheduled.
23. While scrutinizing the bids during opening of bid documents priority will be given to local/adjacent district jurisdiction suppliers in order to avoid any future dislocations during supply of materials.
24. Priority shall be accorded to the suppliers with past experience of supplying the said item to different public offices.
25. 5% Security Deposit (SD) amount of total value of warranty covered items may be deduced from your bill at the time of payment. Same will be refunded after complete of Warranty and Maintenance period.
26. Jurisdiction: If any dispute(s) arise(s) in respect of bids shall be settled mutually between bidder and the procurement committee within the jurisdiction of Bhadrak District only.
27. Amount should be round off as per Govt. provision.
