ANNEXURE-I

TERM AND CONDITIONS FOR AUCTION OF VEHICLE

1. The Tenderer shall be pay earnest money deposit amount of Rs 1000/- (Rupees One Thousand ) Only in shape of bank draft in favour of CDPO, Bhadrak and the same shall be subject to refund except in case of the highest offer accepted by the competent authority.
2. The Highest Tenderers shall be deposit 25% of the amount immediately after announcement and the rest within 7days of the approval of the order.
3. On failure to make payment as aforesaid the deposits ( including earnest money ) shall be forfeited and the vehicle put to fresh tender.
4. The vehicle shall not be delivered of the tenderer/ party until after full payment and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.
5. The tender / party shall remove the vehicle from the site within 7 days from the date of depositing the full amount of the tendered / negotiated money. Custody or safe guard of the vehicle shall be the responsibility of the tender/ party and no claim or compliant on hat account shall be admissible.
6. On failure to the remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the tendered / negotiated money shall be charges for each day or part of the day till the removal of the vehicle from the site.
7. Where the ground rent so charges exceeds the sale price deposited, the tenderer/ party shall case to have any right on the vehicle .The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Government free from all encumbrances and disposed of by fresh sealed tender as the case may be.
