Sealed Tender is hereby invited by the District Fisheries Officer, Bhadrak from the intending bidders/ reputed firms for Wall Painting on Fisheries programme at 218 Gram Panchayat of Bhadrak District. The Tender documents must be submitted through registered post/ Speed Post service latest by 04.01.2024, 5.30 PM and the Tender will be opened on 05.01.2024 at 11.30 AM in the Office chamber of District Fisheries Officer, Bhadrak. The Tender should reach in Sealed cover with superscribing with "Tender for Wall Painting under IEC schemes of District Fisheries Officer, Bhadrak."

#### **ELIGIBILITY CRITERIA: (SELF ATTESTED DOCUMENTS REQUIRED TO BE SUBMITTED)**

1. The bidder must be a registered Firm/ Partnership firm/Sole Proprietorship firm.
2. The bidder must have valid GST registration certificate.
3. The bidder must have a valid PAN.
4. The bidder must have a local office in state of Odisha. Proof of address must be attached.
5. The bidder should have an average minimum turnover of Rs. 10.50 Lakh in last three years (i.e. FY 20-21, FY 21-22, FY 22-23). The bidder must submit annual turnover certificate of last three financial year (FY 20-21, FY 21-22, FY 22-23) duly certified by C.A (Annexure – II).
6. The bidder must furnish GST clearance certificate of last three quarters.
7. Minimum 2 years of experience in Wall painting in Govt. / PSUs (Work order to be furnished)
8. The bidder must not have been barred or blacklisted by any State/ Central Government Departments/ Govt. Agencies or any PSUs (A declaration to this effect shall be furnished).
9. The Tender document should accompany with Profile of the Agency as Bidders profile (Annexure-I) and Financial Bid (Annexure-III)

10. The assignment period shall be for 7 days from the date of the work order. The assignment period may be extended basing on the satisfactory performance and need of the Authority.
11. The tender document shall accompany with 1% of the tender amount Rs.17440.00 as EMD while participating in the tender process. Again the selected bidder has to furnish 1% of the tender amount i.e. Rs.17440.00 as initial security deposit before issue of work order .The EMD/ISD should be in shape of TDR/KVP/NSC/Postal saving pass book (From any nationalized bank payable at Bhadrak) duly pledged in favour of District Fisheries Officer, Bhadrak and in no other form.

The Payment to the agency on the assignment will be made by assigning authority/office for the delivers submitted by the agency and as per the approved rates of the DFO, Bhadrak after successful completion of the assignment along with the GST bill and completion certificate by concerned block AFO.


