2. The supplying agency should have PAN/TIN & up to date GST clearance Certificate
3. It has not been blacklisted by any Government Organization
4. Rates should be quoted inclusive of all charges of GST and other taxes as applicable including transportation.
5. The Executive Officer will have no liability regarding transportation, loading and unloading of materials and all the materials ordered for shall be delivered at the designated place in good condition. The defective or damaged printed material if any will be replaced by the printing press/agency
6. The quotationer should deposit EMD of Rs. 10,000/- (Rupees Ten Thousand) only in shape Demand draft in favour of Executive Officer Dhamnagar NAC payable at SBI main Branch Binka. The EMD which will be refunded after successful completion of supply. EMD of unsuccessful quotationers shall be refunded after finalization of the quotation process.
7. Self-attested certificate of MSME for exemption of EMD.
8. Money receipt in original in support of purchase of quotation papers or Demand Draft of Rs.2000/- (Rupees Two thousand) only payable at SBI Main Branch Binka in favour of Executive Officer, Dhamnagar NAC.
