INVITATION FOR BIDS (IFB)

BID IDENTIFICATION NO- 2/2024-25, Dt -21/02/2024

Block Development Officer, Bhandaripokhari on behalf of Panchayat Samiti, Bhandaripokhari invites Percentage Rate bids in single sealed cover system for the construction of works as detailed below, from the eligible contractors of equivalent grade/class registered with central Govt./MES/Railways for execution of civil works. The proof of registration from the appropriate authority along with ITCC and system generated GST registration and copy of PAN shall be enclosed along with the bid. The bidders may submit bids for any or all the following works in the office of the Panchayat Samiti, Bhandaripokhari. *One bidder can submit one bid only for a particular work. The cover containing the bid should be super scribed as Tender for the work " name of the work as the case may be".*

1. Bid documents consisting of specifications, and the set of terms & conditions of contract and other necessary Documents can be seen in the Website www.bhadrak.nic.in or purchased from this office on payment of specified amount (non-refundable) during office hours. The bidders who will download the document online must have to obtain the money receipt towards cost of document from this office before the scheduled time.
2. Bids must be accompanied with bid security and receipt against cost of bid documents of the amount as specified for the work in the table along with bid documents. The cost of bid documents shall be in shape of demand draft issued from any Nationalized Scheduled Bank located in the State of Odisha in favour of Block Development Officer, Bhandaripokhari. Bid security will have to be in any one of the forms as specified in the bidding documents and shall have to be valid for 45 days beyond the validity of the bid. Bids shall be received in the office of Panchayat Samiti, Bhandaripokhari upto 5.00 PM of 29/02/2024 except Govt. holidays.
3. Bids received shall be opened at 11.00 A.M of 01/03/2024 on in the office of the Panchayat Samiti Bhandaripokhari in the presence of the bidders or their authorized representatives who wish to attend on behalf of them. In case if the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and date.

5. The authority reserves right to reject/cancel the bid(s) without assigning any reason thereof.




