/Estt; In pursuance of Rule-6 of Odisha Ministerial Service (Method of Recruitment and Conditions of Service of Junior Assistant, Senior Assistant and Section Officers in District Offices and Offices Sub-ordinate Offices thereto) Rules, 2019, the following 47(Forty Seven) candidates who have come out successful in Combined Recruitment Examination(CRE)-2023 published vide Notification No.204(C)/ OSSSC Dated 26.02.2024 and as per recommendation of the Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar are hereby appointed as Junior Revenue Assistant on regular basis in Cell-1 Level-4 of the first schedule of the Pay Matrix under Odisha Revised Scale of Pay Rules,2017 pertaining to Revenue & Disaster Management Department.

The appointees shall be on probation for a period of two (02) years and their appointment is purely temporary and subject to verification of character and antecedents. On receipt of adverse report on character and antecedents at any point of time during the said period, their services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of clause (h) of Explanation under Rule-13 of the Odisha Civil Service (Classification, Control and Appeal) Rules,1962 reinforced in G.A Department Resolution No.34438/Gen Dated 20.11.1999.
