

**PROCEEDINGS OF THE MEETING OF SELECTION COMMITTEE ON DT  
27.06.2024 FOR ENGAGEMENT OF PART TIME INSTRUCTORS IN  
PHYSICAL EDUCATION AMONG SPORTS CANDIDATES OF BHADRAK  
DISTRICT**

A meeting of Selection Committee for engagement of Part Time Instructors in Physical Education under the category of Sports candidates of Bhadrak District was held on Dt 27.06.2024 at 5.00 pm under the Chairmanship of Additional District Magistrate, Bhadrak at Collectorate, Bhadrak.

The following members are present in the meeting-

01. Additional District Magistrate, Bhadrak
02. DEO-cum- DPC, SS, Bhadrak
03. District Welfare Officer, Bhadrak
04. District Employment Officer, Bhadrak

At the outset, District Project Coordinator, SS, Bhadrak welcomed all the members of the Committee and briefed the house about the purpose of the meeting. The DPC, SS, Bhadrak briefed the house that, as per advertisement No 4905 Dt 24.08.2015, there was vacancy for 123 posts for Part Time Instructors in Physical Education out of which:

- a. 59 posts have been filled up among the candidates having requisite qualification, i.e, +2 with C.P.Ed, B.P.Ed, or M.P.Ed and Sports Persons issued with ID card from Sports & Youth Service Department
- b. 37 posts have been filled up from among the applicants having National Level Sports Participation certificate with a minimum of +2 qualification.
- c. 1 post has been filled up as per the direction of Hon'ble High Court, Cuttack in WP( C ) No 2685/2017 filed by Rashmita Tripathy-Vs- State of Odisha.
- d. 2 posts to be kept reserved keeping in view of the direction of Hon'ble High Court, Cuttack in WP( C ) No 28754 of 2019 ( Prafulla Ku Tripathy -

- e. The remaining 24 posts are laying vacant which are to be filled up from among the applicants having Sports participation certificate & as per the verification report received from Sports & YS Department

DPC further briefed the house that, as decided in the Committee meeting held on Dt 18.11.2019 & 03.01.2020, National Level Sports persons were given priority over the candidates having State level Sports participation certificate and accordingly the Merit list was prepared only for National Level Sports persons (47 nos) out of which 37 candidates attended the certificate verification and engagement order has been issued to 37 candidates. As decided by the Committee in the said meeting, 13 posts were kept reserved in respect of 13 candidates who had submitted National Level Sports participation Certificates but whose verification report were not received from the Sports & Youth Service Department. Since, the verification report against 93 sports certificates were not received from Sports & Youth Service Department, the Merit List in respect of State Level Sports Persons was not prepared.

DPC further briefed the house that, The Sports & Youth Service Department has communicated the verification report regarding genuineness of the Sports Certificates in a series of letters at different intervals. The details of the Letters/ verification report is annexed at Annexure-I. The last verification report has been communicated vide Letter No 8132 Dt 27.02.2024 wherein the Sports & Youth Service Department has given verification report against 90 candidates in 2 separate lists, i.e, List of Eligible cases (31 nos) & list of Ineligible Cases (59 nos).

DPC further briefed the house that, after receiving the verification report against the pending sports certificates it is found that, the verification report against 3 certificates of Sri Asutosh Parhi & 1 certificate of Itishree Panigrahi have not been received from Sports & YS Department. It is also found that, 11 candidates names have been repeated owing to submission of double application

DPC further briefed the house that, on verification of sports certificates, the Sports & YS Department in their Letter No 1881 Dt 28.02.2017 & Letter No 3003 Dt 22.03.2017 has given their observation that East Zone Championship/ Inter-zone Championship are not National Championship, but in subsequent Letter No 8992 Dt 04.09.2017, Letter No 12699 Dt 24.12.2017 & in Letter No 4140 Dt 12.04.2018 has given their observation that competitions like Federation Cup, East Zone & Inter zonal Competitions are not treated as National Level Competitions rather they may be treated at par with State Level Sports Competitions for award of Marks. As such, the Committee decided that, in case of the candidates having their participation certificates in East Zone Championship/ Inter-zone championship/ similar other Zonal level Championship, the same shall be treated as State level participation certificate and not National Level Certificates & marks shall be awarded as per the verification report received from Sports & YS Department.

After a threadbare discussion, the Committee decided that, the Merit list of the candidates shall be prepared strictly, as per the verification report & observations/ genuineness of the Sports certificates issued by the Sports & Youth Service Department. The Committee prepared the Merit List separately for the National Level Sports persons (in respect of 13 candidates who had submitted National Level Sports participation certificate but whose verification report were not received from Sports & YS Department) & and another ( in respect of 218 candidates) for the candidates having State Level Sports participation certificates. On preparation of the Merit List for the candidates




having National Level Sports participation certificates, It is found that, out of 13 candidates, only 2 candidates are found eligible & 1 candidate, (Asutosh Parhi) against whom the verification/ genuineness report for 3 certificates are still pending. A Separate Merit List for the candidates (218 nos) having State Level Sports Participation Certificates is also prepared, as per the verification report & observation/ genuineness of Sports certificates issued by Sports & YS Department.


It is decided by the Committee that, the Merit List of both National Level & State Level candidates shall be placed to the Collector, Bhadrak for kind approval & publishing of the same in the District Website as well as in the Local News Paper for wide circulation & to invite objection, if any from the candidates within a period of one week time from the date of publication of the Merit List.


