

**PROCEEDINGS OF THE MEETING OF SELECTION COMMITTEE ON DT
09.08.2024 FOR ENGAGEMENT OF PART TIME INSTRUCTORS IN
PHYSICAL EDUCATION AMONG SPORTS CANDIDATES OF BHADRAK
DISTRICT**

A meeting of Selection Committee for engagement of Part Time Instructors in Physical Education under the category of Sports candidates of Bhadrak District was held on Dt 09.08.2024 at 5.00 pm under the Chairmanship of Collector & District Magistrate, Bhadrak at Collectorate, Bhadrak.

The following members are present in the meeting-

01. Collector-cum-Chairman, SS, Bhadrak
02. Additional District Magistrate, Bhadrak
03. DEO-cum- DPC, SS, Bhadrak

At the outset, District Project Coordinator, SS, Bhadrak welcomed all the members of the Committee and briefed the house about the purpose of the meeting. The DPC, SS, Bhadrak briefed the house that, as per advertisement No 4905 Dt 24.08.2015, there was vacancy for 123 posts for Part Time Instructors in Physical Education out of which 96 posts have been filled up.

1 post has been filled up as per the direction of Hon'ble High Court, Cuttack in WP(C) No 2685/2017 filed by Rashmita Tripathy-Vs- State of Odisha. Further, 2 posts to be kept reserved keeping in view of the direction of Hon'ble High Court, Cuttack in WP(C) No 28754 of 2019 (Prafulla Ku Tripathy - Vs- State of Odisha) & in WP(C) No 28760 of 2019 (Subhashree Nayak - Vs- State of Odisha)

After receiving the verification report from the Sports and Youth Service Department, against the pending sports certificates, vide Letter No 8132 Dt 27.02.2024, the Draft Merit List was prepared and as per the approval of Selection Committee, a Notice No 1456 Dt 29.06.2024 along with Draft Merit

was published in the District website, Bhadrak for wide publicity and in case of any objections, the candidates were requested to file their objection by Dt 06.08.2024.

DPC further briefed the House that, in pursuance to Notice No 1456 Dt 29.06.2024, 10 nos of objections are received from the candidates by Dt 06.08.2024.. The major objection filed by the candidates are as follows:

1. To consider the National/ State Netball Championship Certificate prior to 2010 as similar certificate has been considered in case of Rasmita Tripathy, as per the direction of the Hon'ble High court, Cuttack in WP(C) No 2685 of 2017 and engagement order has been issued in favour of Rasmita Tripathy.
2. Not to consider the East Zone/ Inter Zone & other Zonal Sports Certificates for preparation of merit list at the State Level.
3. Inclusion of Sports Certificates for Merit.

After a threadbare discussion, the Committee decided that, the objections will be complied as per the guideline & instructions communicated by the Government & the verification report/ observations/ remarks communicated by Sports & Youth Service Department, Odisha. The objections are scrutinized by the Selection Committee and the same are rejected. A consolidated report on compliance of the objections is prepared & attached as Annexure-A. The Merit list of the candidates is prepared strictly, as per the verification report & observations/ genuineness/ remarks issued by the Sports & Youth Service Department. The Committee prepared the Merit List separately for the National Level Sports persons (2 Nos) and another for the candidates having State Level Sports Participation Certificates. On preparation of the Merit List for the candidates having National Level Sports participation certificates, It is found that, 1 candidate, (Asutosh Parhi) against whom the verification/ genuineness report for 3 certificates are still pending. So the Committee decided that, 1 post shall be kept reserved for the candidate (Asutosh Parhi). In case his certificates are found





not genuine or no weightage marks are given, then the post will be filled up from among the State Level Sports Persons as per merit. It is further decided by the Selection Committee that out of the 26 posts, 2 posts shall be kept reserved for the Court cases in respect of WP(C) No 28754 of 2019 (Prafulla Ku Tripathy - Vs- State of Odisha) & in WP(C) No 28760 of 2019 (Subhashree Nayak - Vs- State of Odisha) and the rest 23 posts (National Level- 2 Nos & State Level 21 Nos) shall be filled up as per merit. The merit list shall be prepared accordingly including the waiting list.



The meeting ended with a vote of thanks to the chair.




