



(d) Reimbursement/refund on variation in price of materials, labour, P.O.L. as per sub-clause (a), (b) & (c) of this clause shall be applicable only in respect of contract of one year or more provided that the work has been carried out within the stipulated time of extension thereof due to reasons not attributable to contractor. Reimbursement is admissible only for the period beyond one year from the date of commencement of the work. However, where the original contractual period is less than one year but subsequently it has been validly extended and the period becomes one year or more, escalation clause shall be applicable only for the balance portion of work to be executed beyond one year provided the delay is not attributable to the contractor.
