1. Technical & Financial Specification of the work:

The agencies/firms/authorized dealers must have valid GSTIN Registration Number, PAN Card, Service Tax registration with previous experience with same type of work. The Quotationer should submit the following document along with the Quotation Submission Form (at Annexure-B): (1) Copy of GSTIN Certificate, (2) Updated GSTIN Return copy, (3) Photocopy of PAN Card, (4) Copy of Work Orders (if any/optional) executed in similar type of work. Also a sum of **Rs.10,000/- (Rupees Ten Thousand)** only shall be deposited by the intending bidders in shape of A/C Payee Bank Draft in favour of the "District Child Protection Society, Bhadrak" and submitted along with the quotation as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders. The undersigned will not make any advance payment to the agency. The agency will have to carry out the entire job on its own. The agency must complete the assignment within 10 days of issuance of work order and supply the items. The payment will be made through NEFT only after satisfactory completion of the work with submission of bills in that regard. After completion of the work, the Agency/Firm needs to submit a Work Completion Certificate to this office showing all items are in good conditions as desired in the Quotation Call Notice/Supply Order.


2. Item Specifications: Specified in **Annexure-A.**




