Sealed quotations /tenders are invited from interested reputed Travel Agencies /Tour operators / private individuals for providing 01(one) no of AC Petrol driven vehicles (TUV300/Bolero/Sumo Gold/Ertiga) having sitting capacity not more than Ten including driver, which shall confirm the following Terms & conditions (Appendix-A) for Paddy Procurement Operation in the office of the CSO-Cum-District Manager, OSCSC Ltd, Bhadrak on monthly rent basis.

1. The service provider shall have a valid OGST registration to participate in the tendering.
2. The service provider, participating in the bidding process under the jurisdiction of Municipal Corporation, shall be registered on GeM platform.
3. The vehicle must be in road worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, Valid Contact Carriage Permit, Proof of up-to-date tax payment etc mandatory for plying of vehicle.
4. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficient experienced in driving transport vehicles.
5. The driver should be well behaved, gentle, and obedient in nature.
6. A sum of Rs 10000/- (Rupees Ten Thousand) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft in favour of the **District Manager, OSCSC Ltd, Bhadrak** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to un successful bidders.
7. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
8. The vehicle must achieve a fuel efficiency of 10 (Ten) K.M. per litre in case of (TUV300/Bolero/Sumo Gold/Ertiga).

The details of the make and year of manufacture of the vehicle, registration No, mileage (K.M covered per litre) and name of the driver with Driving License No and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender(Appendix-B)
10. The Quotation completed in all respect should reach the undersigned on or before **30.12.2024 by 3.00 P.M.** and shall be opened on the same day at 4.00 P.M in presence of the bidders or their representatives.
