

4. The bidder should be original manufacturer or their authorized dealer of the equipments stated above and providing adequate service after supply of the equipments.
5. The bidder has to produce documentary proof towards being manufacturer or their authorized dealer.
6. Our weighbridge should be de install from the side
7. The project is on turnkey basis the new weighbridge along with civil work will be done by the supplier.
8. The bidder should have dedicated service centre or corporate office in the state of Odisha for delivering of speedy services. Necessary documents to be submitted for its proof.
9. The bidder has to be producing proof of successful execution of similar nature of supply for at least 3 financial years across RMCs in Odisha or any Govt offices in Odisha.
10. The bidder has to submit valid Authorization certificate from the manufacturer/ dealer/Distributer for the item quoted.
11. The supplier of Machinery/Equipment should provide both theoretical and practical training after commissioning the machinery or at appropriate stage.
12. The Bidder having ISO certificate and Trade License, copy must be enclosed.
13. The price quoted should be inclusive of all taxes, delivery and installation.
