
**Terms and Conditions for Printing & Supply of packaging materials  
for THR under MSPY for Bhadrak District.**

1. Sealed tender papers are invited from the intending printing press/Agencies/firms for printing & supply of packaging materials for THR under MSPY of Bhadrak district.
2. The tender papers can be obtained from the Office of the District Social Welfare Officer, Bhadrak on payment of Rs 10,000/- (Rupees Ten Thousand) only which is non refundable in shape of D.D. drawn in any Nationalized Bank in favour of DSWO, Bhadrak towards the cost of tender paper during the office hour on any working day from the date of publication of this Notice to **till dated 20-03-2025** These documents can be downloaded from the district website **<https://bhadrak.odisha.gov.in>**
3. The tender will be in two parts i.e. **Technical Bid (Part-I) and Financial Bid (Part-II)**. The bidders should submit their technical bid and financial bid separately in two sealed envelopes and put into another cover superscripted as "**Printing of Packaging Materials for THR**" for 13 THR units of Bhadrak district. Earnest Money Deposit (EMD) of Rs 30,000/- (Rupees Thirty Thousand) only in shape of Demand Draft pledged in favour of DSWO, Bhadrak. The tenderer will submit the valid documents for EMD Exemption. Tenders without E.M.D. will be liable for rejection. E.M.D. of successful bidder will be turned in to security money. If the firm fails to execute the contract, the security money will be forfeited. The security Deposit will be released after supply of materials and finalisation on settlement of Accounts. The E.M.D. of unsuccessful bidders shall be refunded after tender process is finalised. Sample of tender items propose for printing through the above tender should be exhibited at the time of opening of the tender papers.
4. Tender paper complete in all respect along with all required documents should reach in sealed cover to the DSWO, Bhadrak on or before 20-03-2025 up to 04:00 ~~A.M.~~ / PM by Registered / Speed post only.
5. Tendered will be opened on 21-03-2025 at 04:00 ~~A.M.~~ / P.M. in the Sadhabana Sabhagruha, Collectorate, Bhadrak in presence of the member of tender committee and tenderers or their authorised representatives. The tender received beyond the scheduled date and time shall not be taken in to consideration.
6. Bidders who would qualify in the technical bid will eligible to participate in Financial Bid.
7. The lowest bidder will be selected for printing and supply of above materials and may be negotiated.
8. The successful Agency has to delivery of the materials within 10 days at 13 THR units of 08 ICDS Projects of Bhadrak district and complete the whole process within 30 days from the date of issue of supply order by the District Social Welfare Officer, Bhadrak, failing which tendering authority reserves the right to approach next highest bidder.
9. Any claim of the Govt. remaining unpaid by the supplier towards this supply shall be recoverable as public demand under the Odisha public demand recovery Act 1962.
10. The tender papers once submitted will not be returned or exchanged.
11. If any question or dispute arises at any time between the parties here touching or arising out of or in respect of this supply, then the same shall be referred to the appropriate court or tribunal constituted by the Govt. of Odisha whose decision will be final, conclusive and binding on both parties.
12. In case of dispute about the quality, the Collector or his authorised representative(s) will cause an inquiry and take suitable action including debarment against the supplier.

13. The price quoted must be inclusive of all Taxes/duties/transportation up to delivery point etc. The rate quoted should be final and the tender shall not be allowed to change the same rate in any circumstances.
14. Mode of submission of application: - Application and requisites with sealed cover superscripted at top the "**Printing of Packaging Materials for THR**" addressed to the District Social Welfare Officer, Bhadrak through Regd. Post or Speed Post or Courier in the office during Office hour except Govt. holidays.
15. The tenderer has to submit the following documents along with the tender paper.
- a) Original Money receipt/DD of tender paper cost.
  - b) Self Attested copy of PAN card.
  - c) Self Attested copy of **GST Certificate** in the name of Firm or its proprietor.
  - d) **Sample of printing items (5 nos sample for each item) in the tender.**
  - e) E.M.D. amounting to Rs 30,000/- in shape of DD from any Nationalized Banks pledged in favour of District Social Welfare Officer, Bhadrak.
  - f) Income Tax Return for last three years (i.e. 2020-21, 2021-22 & 2022-23)
  - g) Last 3 years Balance Sheet not less than Rs 12,00,000/- (Rupees Twelve Lakh) certified by the Chartered Accountant. (i.e. 2020-21, 2021-22 & 2022-23)
  - h) Original tender paper, Technical Bid, Financial Bid paper duly signed by the tenderer as a token of acceptance of terms and condition.

17. Statutory Tax deduction may be made during the time of payment as per Govt. Norms.
