01. The rate of supply of different items should be inclusive of all transportation charges, loading and unloading charges and all taxes etc.
02. The quotationers are to enclose the attested copy of the following documents along with the quotation paper and the original certificate is to be produced for verification if felt necessary at the time of finalization in the quotation.
 - (a) Copy of GST registration certificate.
 - (b) Copy of the PAN Card.
 - (c) Copy Similar Work Experience document if any.
03. The sealed quotations should reach ORMAS, Zilla Parishad Office, At-Charigharia, Po-Madhabnagar, Dist-Bhadrak on or before 09.06.2025 by 11.30 A.M through Registered Post / Speed Post / courier/Drop box.
04. The quotation paper & sample can be obtained from the Office of the ORMAS, Zilla Parishad, Bhadrak with effect from 03.06.2025 to 09.06.2025 up to 11.30 A.M.
05. The quotation paper will be opened by the Committee on 09.06.2025 at 12.30 PM onwards in presence of the quotationers or their authorized representatives in the Office of the CDO-cum-E.O, Zilla Parishad, Bhadrak.
06. The quotation received beyond the stipulated date and time and without the above required documents should be liable for rejection.
07. The printing work will be treated as a package of work. So the lowest quoted cost (all items unit cost) will be taken into consideration while finalizing the bidder.
08. The successful quotationer should supply the materials before 01 (One) days of the mela.
09. The rates can be negotiated depending on the situation prevailing at the time of opening and finalization of the quotation.
10. The bidder should have adequate past experience for the above work and submitted documentary evidence for past experience.
11. The payment will be made on successful completion of work as per the Govt. procedure and norms.
12. The contract of quotations should be valid for one year from the date of issue of work order.
12. Quantity of the material may be increased or decreased marginally.
