The Tenderer shall deposit the tender processing fee of Rs.1000/- (Non-refundable) in State Bank of India, Bhadrak Main Branch Account No – 11403399856, IFSC Code No – SBIN0000036 through online transfer and submit the Xerox copy of the deposit challan / online transfer slip along with bid for verification.

The tenders will be received through Courier/Regd. Post / Speed Post only and should reach in the office of the undersigned on or before Dt. **13.08.2025 upto 05:00 PM**. No short tender documents shall be accepted after the expiry of scheduled date and time for receipts of bids. The tenders will be opened on Dt. **14.08.2025 at 11 AM** in presence of the committee members and the tenderers or their authorized representatives.

3. The empanelment supplier will be selected on the basis of who quoted lowest price in total cost.
4. The approved empanelment supplier shall have to supply the required implants within 48 hours issue of order to meet the emergency.
5. The approved empanelled supplier shall have to execute / supply order in full. In any case the prescribed implants are not available with them, and then it is the responsibility of the approved supplier to make it available.
6. The approved empanelled supplier shall have to sign MOU with the undersigned before execution of the contract which is valid for one year from the date of signing of MOU. Also it can be extended further more periods observing on the performance of the supplier.
07. The purchase shall be made on credit basis and the payment will be released as early as possible and availability of funds through IFMS.
08. If any dispute/irregular supply/cancellation of supply order by the approved supplier will be found during the contract period, no further purchase will be made from the supplier.
09. The authority reserves full rights to accept or reject any or all proposals without assigning any reason thereof.
10. In the event of any dispute out of the contract, such dispute should be subject to the Jurisdiction of the Civil Court Bhadrak or High Court, Odisha.
11. All the documents shall be numbered and duly attested by the tenderer otherwise will be rejected.
