
Sealed tenders are invited by the CDAO, Bhadrak from the intending bidders for auction of farm Ponds, Bund area & Coconut trees available in the premises of Govt. seed farms, Bhadrak for the year 2025-26. The bidders should reach the undersigned with their bids in sealed cover on or before 10.09.2025 at 3:00 PM in the Office of the CDAO, Bhadrak as per the following terms and conditions. The authority reserves the right to accept or to cancel the bids whenever necessary. The bidder has to deposit Rs. 1,000/- (Rupees one thousand) in shape of cash only towards earnest money in the office of the undersigned on or before 3:00 PM on 10.09.2025. The amount will be refunded to the un-successful bidders in any office day after completion of the auction.

TERMS & CONDITIONS: -

1. The decision of the auction committee is final. If the price quoted by the bidder is lower than the off-set price fixed by District level committee, authority may call again for auction.
2. The offset price fixed by District Level committee is mentioned below.

3. The bidders have to deposit the earnest money by cash in the office of the undersigned along with the tender papers and Xerox copy of the Adhar-card.
4. The tender papers will be opened by the auction committee at 4:00 PM on Dt. 10.09.2025.
5. The bidders have to attend the auction committee.
6. The successful bidder has to deposit the auction amount after completion of the auction. If one fails to deposit the entire amount on the same day the 1st bidder will be cancelled & 2nd bidder will be accepted.
7. The bidder who will take the lease of the farm pond cannot deny for utilization of water for irrigation purpose to save the crops & the office may utilize the water of pond at any time.
8. The bidder cannot execute any programme after completion of auction period.
9. If the successful bidder wants to take water from bore well in case of shortage of water, he/she to pay the charges for the running of bore well on hourly basis. The rent is @ Rs. 140/- per hour as decided by the committee if such case arises.
10. The successful bidder should execute an agreement with the undersigned for the period of auction.
