

**PROCEEDING OF THE DISTRICT LEVEL SELECTION COMMITTEE MEETING OF
SCHOOL FOR THE BLIND FUNCTIONING AT SHRADHALAYA(IIC), DHAMNAGAR,
BHADRAK HELD ON 23.10.2025 AT 12.00 NOON.**

A meeting of District level selection committee of School for the Blind functioning at Shradhalaya (IIC), Dhamnagar, Bhadrak was held under the Chairmanship of Collector & District Magistrate, Bhadrak on 23.10.2025 at 12.00 Noon in his Office Chamber.

The following members were present in the meeting.

At the outset, DSSO Bhadrak welcomed all the members of the committee and discussed the aims and objective of the meeting. He also discussed about filling up the vacant posts i.e.

- (i) Assistant Teacher (T.I.)- One post
- (ii) Music Teacher (Vocal)- One post
- (iii) Attendant (Male)- One post

The Collector -Cum-Chairman of the District Level Selection Committee and other members wanted to know the requisite qualification for the above post and the process of advertisement as per Govt. Guidelines to invite applications. DSSO, Bhadrak placed in details before the committee, that advertisement was done in two daily odia widely circulated news papers and Bhadrak District web portal (bhadrak.odisha.gov.in).

The Collector & District Magistrate, Bhadrak instructed to DSSO, Bhadrak to discuss about status of the applications received. DSSO, Bhadrak placed the status as given below.

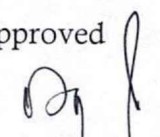
Next to Manas Sethi, the meritorious candidates SI No-02 of the Final merit list was enlisted in the waiting list.

The meeting was ended with vote of thanks to the Chair.

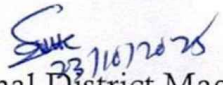

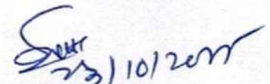
