QUOTATION CALL NOTICE

Sealed quotations are hereby invited from interested reputed travel agencies/Tour operators or private individuals for providing 1 no of diesel driven vehicle like **TUV 300/Sumo Gold/Ertiga/** within maximum hire charges of **Rs-37,200/-**(Thirty-seven thousand two hundred) per month with minimum average in 10 kms per litter having sitting capacity not less than seven including driver, which shall confirm to the Terms and conditions (Annexure-I) for officials use in the office of the Child Development Project Officer, Bonth.

- 1.The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, Pollution Certificate, valid contract carriage permit, proof of up-to-date tax payment etc. which are mandatory for plying of the vehicles. Preference will be given to new vehicle which is use less than 6 month old from the date of initial registration.
- 2.The Driver of the vehicle must have a valid Driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3.The Driver should be well behaved, gentle and obedient in nature.
- 4.A sum of Rs.1000/- shall be deposited by the intending bidders in favour of CDPO,Bonth and receipt submitted along with the tender as security deposit .After completion of tender process ,the amount will be refunded to unsuccessful bidders.
- 5.The monthly rate of hire charge has to be quoted separately in the general bid information (Excluding fuel and lubricants) subjected maximum to 25000/-per month.
- 6.The vehicle must achieve a fuel efficiency of 10 Kms per litre.
- 7.The hire charges will be released as per availability of funds in POL BOR.
- 8.The details of the make and year of manufacture of the vehicle, registration number mileage (Kms covered per litter) and name of the Driver with driving license no and period of validity should be specifically provided in the general bid information to be furnished with the quotation in Annexure-II

9.The quotation completed in all respect should reach the undersigned on or before **Dt-17.01.2026** by 12.00 A.M and shall be opened on the same day at-2.00 pm in presence of the bidders or their authorized representation.

10.Interested bidders may submit their seal tender in the prescribed format superscripting Application for hiring vehicle on monthly hiring basis for ICDS Project Bonth on cover of the envelopes to the ICDS Project, Bonth through speed post/Registered post/By person.

11.The application form of quotation/tender containing General Bid information and Term and condition for hiring of vehicle etc. will be available with CDPO, Bonth office on payment of Rs. 100/- from 10 AM to 04 PM or can be downloaded from Govt. website [https:// bhadrak.odisha.gov.in](https://bhadrak.odisha.gov.in) from Dt.06.01.2026 to 17.01.2026.. In case of the application form is downloaded from Govt. website , the applicant shall furnish a demand draft for an amount of Rs.100/-(Rupees One hundred) only towards the cost of application along with the application.

ANNEXURE-I

Terms & Conditions for Hiring of Vehicles

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles during the period of contract. shall have all necessary valid MV documents such as valid registration certificate, insurance certificate, Pollution Certificate, fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc. And DL of the Driver available all the times. The office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life /injury made to any person or damages to any property on account of use of hired vehicle in any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid on monthly basis is final and do not include cost of diesel, which is to be paid separately basing on the actual consumption of POL as per government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box and differential coolant, tyres and tubes, battery etc. Will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good Driver and the salary of the Driver shall be borne by the owner.
4. In case of breakdown for reason whatsoever, the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle dose not report regularly. The authority will be at liberty to reject the agreement and may engage vehicle from other sources.
6. The Vehicle shall report on duty for minimum of 25 days in a month.
7. In case of any emergency the driver will have to report on duty as per the requirement of the hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) or selected bidder will be paid in every succeeding month. as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be of more than 3years old from the initial registration and also must be in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give "one month notice" and terminate the agreement.

11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement. It shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

12. The vehicle cannot be used for any private/commercial purpose beyond office hours or during holidays.

13. Authority has reserved right to cancel/modify/add/delete the existing terms and conditions without assigning any reason thereof.

14. Any claim shall be mitigated these jurisdictions only.
