**Provisional notification showing division of Wards and Reservation of Seats in
the Tihidi Notified Area Council**

NOTIFICATION

Whereas, the draft notification bearing no. 175/G&M dated 12-02-2026 was published in **Form-XXI** of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 inviting objections and suggestions from all persons interested in respect of the said draft notification showing the division of the area of the **TIHIDI Notified Area Council** into wards and reservation of seats thereof on or before the date of expiry of the period of ten days;

And, whereas, objections and suggestions received within the period so specified have been duly considered.

Now, therefore, in exercise of the powers conferred by the sub-section (3) of Section 12 of the Odisha Municipal Act, 1950 (Odisha Act 23 of 1950), the District Magistrate, Bhadrak do hereby divide the area of the said "Notified Area Council into **14 (fourteen)** wards as specified in Column (2) of the **Statement-I** below with the description and boundaries of the said wards against each column (3) and (4) respectively thereof for the purpose of ensuing election of Councillors to the same determine the Wards as specified in Column (2) of **Statement-II** below in which the seats reserved under Section 11 of the said Act shall be set assigned against each in Column (3) thereof.

Any person aggrieved by the orders passed by the District Magistrate under sub-rule (4) of Rule 2-A may file an appeal before the State Government under the second proviso to sub-section (3) of Section 12.

In continuation of this office Letter No. 175 / Gen & Misc dated 12.02.2026 regarding the notification for division of wards and reservation of seats of the Tihidi Notified Area Council, objection petitions were received from certain localities.

The undersigned was pleased to consider the said objection petitions and fixed 25.02.2026 as the date of hearing. Notices were duly served upon the petitioners. On the scheduled date, the hearing was conducted in the presence of the petitioners and the concerned district-level officers.

After careful hearing of the objections and upon examination in accordance with the prescribed provisions of the Odisha Municipality Act, particularly under Section 11 of the said Act and the compliance reports received from the Executive Officer Tihidi NAC cum BDO Tihidi, the objections are hereby found to be devoid of merit and therefore rejected.

Accordingly, the notification regarding the division of 14 (fourteen) wards, as specified in Column (2) of Statement-I, along with the description and boundaries of the said wards as mentioned against each in Columns (3) and (4) respectively, for the purpose of the ensuing election of Councillors, is hereby confirmed. Further, the wards specified in Column (2) of Statement-II, in which seats have been reserved under Section 11 of the said Act, shall remain unaltered.
