The sealed cover must be mentioned clearly on the front cover envelop, the name of the market yard, room no and size of room with clearly mentioned the floor and all required document also attached with application form. This should be reached to the RMC office Chandbali by 3.00 P.M. of dt. 15/04/2026 positively through registered post/speed post.
4. The tender paper will be opened on dt.17/04/2026 at.11.30 A.M. in the office of the RMC Chandbali , Sastrihat, Bhadrak.


1. Photo copy of receipt of application cost of Rs.500/- (Original)
