
Final notification showing division of Wards and Reservation of Seats in the Dhusuri Notified Area Council

NOTIFICATION

Whereas, the provisional notification in **Form-XXII** of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 showing the division of the Dhusuri Notified Area Council into Wards and Reservation of Seats as required under sub-section (3) of section 12 of the Odisha Municipal Act, 1950 was published in the notification bearing no. 274/G&M dated 26-02-2026 for the purpose of giving opportunity to the persons to file appeal, if aggrieved against the decision of division of wards and reservation of seats in the said council:

And whereas, no appeal has been filed before the Appellate Authority against the issue of order in the said provisional notification in **Form-XXII** within the stipulated period as intimated by the State Government in their letter No.9589 dated. 30-03-2026.

Now, therefore, in exercise of the powers conferred by the sub-section (3) of Section 12 of the said Act, the District Magistrate, Bhadrak do hereby divide the area of the Dhusuri Notified Area Council into **14 (fourteen)** wards as specified in Column (2) of the **Statement-I** below with the description and boundaries of the said wards against each in column (3) and (4) respectively thereof for the purpose of ensuing election of Councillors to the same and determine the Wards as specified in Column (2) of **Statement-II** below in which the seats reserved under Section 11 of the said Act shall be set assigned against each in Column (3) thereof.
