The willing bidder may purchase the above tender schedule during the said time period.
2. Receipt of Tender Paper: - The detailed tender Schedules of the above-mentioned works will be received in the office of the Superintending Engineer, RWS&S Division, Bhadrak during the office hours on any working days from **dt. 08.05.2026 to 14.05.2026 up-to 1.00 P.M.**

3. Submission of Tender: - The sealed tender duly filled in properly both in figure and words in respect of all items of works must be signed by the contractor in each and every page with a token of acceptance of the terms & conditions as laid down in the DTCN. Name of the work may be mentioned on the envelope clearly
4. Due date of opening of Tender: - The sealed tenders will be opened in the office of the undersigned at **9.30 A.M on dt. 15.05.2026** in the presence of the tenderers or their authorized agents who will be present at the time of opening. If the schedule date of opening will fall on holiday, the tender will be opened on next working day of the same time & place.
5. Tender document consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the offices issuing the documents and office of the undersigned during office hours every day except on Sunday and public holidays till last date of sale and receipt of tender papers. **Govt. of Odisha Performance security shall be obtained only from lowest accepted bidder when the bid amount is less than the estimated cost put to tender.**

The Additional Performance Security should be deposited in shape of TDR pledged in favour of Executive Engineer RWS&S Division, Bhadrak at the time of agreement.

7. Which evaluating tender for grant of concession to S.C/ ST contractors, Govt. Circle No. 16/37 – 27748, date 11.10.1977 will be considered and provision made in the OPWD code Vol-I & Vol-II will also be followed. Price preference of 10% will be given to contractor belonging to SC / ST category over general caste contractor on submission of affidavit and caste certificate by the SC /ST contractor for availing the benefit of price preference.
8. In case of the Engineering Contractor not having availed EMD exemption in more than 2 works, the said facts have to be clearly mentioned in the affidavit i.e:- "Being an Engineering Contractor I have not availed EMD exemption in more than 2 works in the financial year 2025-26.
9. The Engineering Contractor has to upload all the pages of license including blank pages for verification of entries made on awarded work with exemption of EMD.
10. The Engineering Contractor belonging to SC / ST category can not avail 10% of price preference over the general caste contractor. He can avail exemption of EMD for 3 Nos of work in a financial year. Facilities availed by SC /ST contractors cannot be allowed to an Engineering Contractor belonging to SC / ST category.
11. Original affidavit along with wanting documents, if any will be received during verification of original documents within a specified period after opening of the tender.
12. The Earnest money deposit (EMD) shall be of Rs.as mentioned for each work and in shape of NSC / Post Office Saving Bank Accounts/Post office Time Deposit Account/ Kissan Vikash Patra/ Bank Guarantee in Schedule Bank duly pledged in favour of Executive Engineer RWS&S Division, Bhadrak payable **at Bhadrak**. EMD in any other form shall not be accepted. The EMD shall accompany the DTCN Part-I General & Technical Bid. Tenders without EMD or with part EMD / un pledged EMD / EMD Partly pledged and partly un pledged / EMD in other forms shall not be considered and such tender shall be out rightly rejected.

13. The bidder shall have to produce an affidavit in support of authenticity of document at the time of bidding. The authority reserves the right to verify the authenticity of the document in case of any doubt or complain.
14. The authority reserves the right to reject any one or all the tenders without assigning any reason thereof.
15. Other details can be seen in the bidding documents.
16. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers as per works Department letter No. 4985/W dated. 28.3.2007.
17. The rates have been arrived exclusive of GST. GST will be paid extra as applicable on production of Tax Invoice.
18. After award of contract, work to be taken up in war footing manner and should be completed within stipulated time period, in case of delay in execution of work by the agency, then 10% penalty will be imposed against him.
