The Authority required sealed Tender/Auction papers from the intending bidders for auction of the Unsold Paddy of Q. 572.60 (Bhadrak Q.106, Dhamnagar Q.382.60 & Agarpada Q.84). The bidders have to deposit Rs. 1000/- (Rupees one thousand) only towards earnest money in the office of the undersigned on or before 22.06.2026 at 4 PM. As per the following terms & conditions, the Authority reserves the right to accept or to cancel the bid whenever necessary.
