Expression of interest (EOI) for selection of FPOs/Cooperatives/Public/Private Cooperation as Value Chain Partner (VCP) under the scheme "NATIONAL MISSION ON EDIBLE OIL-OILSEED (NMEO-OS)" for the year 2026-27.

In pursuance of letter no-479 dated - 26.05.2026 of DA & FP(O) ,Expression of Interest is invited by the Chief District Agriculture Officer, Bhadrak from the experienced and interested **Farmer Producer Organisation (FPO)/ Cooperatives/Public/Private Cooperation** operating in the oilseed sector for selection of **Value Chain Partner (VCP)** under the scheme "**NATIONAL MISSION ON EDIBLE OIL-OILSEED (NMEO-OS)**" for the year 2026-27. Interested FPOs/Cooperatives/Public/Private Cooperation are requested to submit their Expression of Interest (EOI) in sealed envelope super scribed as **application for engagement of Value Chain Partner (VCP)** for implementation of the scheme "NATIONAL MISSION ON EDIBLE OIL-OILSEED (NMEO-OS)" for the year 2026-27 for Bhadrak district by registered/ speed post/ physical submission in office hours and working day only with the following documents.

Selection Criteria For FPOs/Cooperatives:-

1. Registration Certificate (Must be Registered under the Companies Act or Cooperatives Act) .
2. Experience of **atleast 3** years working in the district where the cluster is formed.
3. Photographs/ Work order of past experiences.
4. At least **200** farmers should be registered in the FPO or Cooperative.
5. Average Annual turn over in the past 3 years should be greater than **9 lakhs**.
6. **Equity of atleast Rs 3 lakhs** by the farmers in the FPO (Recipients of any Equity grant by the Government shall be given preference)
7. FPOs formed under the 10000 FPOs scheme, FPOs associated with oilseeds registered with public agencies such as NAFED,NSC-OS etc shall be given preference subject to fulfilling of eligibility criteria.


Selection Criteria For Public or Private Corporations:-

1. Centre or State Public sector undertaking working in the seeds,edible oils,fertilizer sector, and Private corporation registered with The Solvent Extractors Association of India (SEA),The Soyabean processors association of India (SOPA),Mustard Oil Producers Association of India (MOPA),Indian vegetable Oil Producers' Association (IVPA),National Seed Association of India (NSAI), Federation of Seed Industry of India (FSII) shall be considered for forming VCPs.
2. Minimum annual turnover of Rs. 10 Cr.

3. No defaults of taxes in taxes in last 3 years.(GST Registration certificate & IT return of last 3 consecutive financial year must be enclosed).
4. Working as a producer of seeds,fertilisers, and edible oil for at least the last 5 years.

The proposals in **email** would not be entertained in this regard. The Expression of Interest (EOI) should be addressed to the office of the Chief District Agriculture Officer, Bhadrak(**Office of the Chief District Agriculture Officer, Bhadrak, At-Bagurai, Po-Madhabnagar, Pin-756181, Dist-Bhadrak**). The last date for receipt of EOI is **22.06.2026 up to 1.30 PM** and the same shall be opened on **22.06.2026 at 4.30 PM** in presence of authorized signatory and representative. **Single application of EOI will also be considered.**
